If any passenger who wish to disembark or stay longer than 24 hours in Oman, should follow the visa obtaining procedures applicable to Oman.

21 ELECTRONIC VISA REQUIRED - For New Zealand – from October 1st 2019 this year, All passengers entering into NZ on a Cruise ship will need to have a NZ eTA, regardless of Nationality, except NZ passport/Residents and Australian Passport Holders
